**NOTICE TO THE PROFESSION AND PUBLIC**  
**ADJOURNMENT AND RESCHEDULING OF MATTERS PRESENTLY SET FOR**  
**SEPTEMBER 19, 2022**

**Purpose**

Further to the [Premier's statement on the national day of mourning to mark the Queen's funeral](#), all Provincial Court locations will be closed on Monday, September 19, 2022. The purpose of this Notice is to direct the adjournment of, and outline the process for rescheduling, matters presently scheduled for September 19, 2022.

**Notice**

1. All court appearances presently set for September 19, 2022 are adjourned.
2. Parties and counsel are required to participate in rescheduling these appearances. The table below sets out the process for rescheduling.

<b>I. FAMILY (including child protection (CFCSA) and maintenance enforcement (FMEA))</b>

On this date, parties and counsel will address rescheduling the September 19, 2022 date with the presiding judge.

Continuation of trial where there <b>is</b> already a scheduled trial date before September 19, 2022 to address rescheduling with the presiding judge (CFCSA, FLA, FMEA)	Parties and counsel will be expected to address rescheduling with the presiding judge at a scheduled trial date before September 19, 2022.
Continuation of trial where there is <b>not</b> already a scheduled trial date before September 19, 2022 to address rescheduling with the presiding judge (CFCSA, FLA, FMEA)	JCM will contact parties and counsel to reschedule.
Family remand list (CFCSA, FLA, FMEA)	<a href="#">Court registry</a> (Registry) will reschedule in consultation with JCMs and also with the Director for CFCSA/FMEA matters. The parties will receive notification regarding the next date they must attend court.
CFCSA Rule 2 case conference	The parties will receive notification regarding the next date they must attend court.
Family settlement conference	The parties will receive notification regarding the next date they must attend court.
Family management conference	The parties will receive notification regarding the next date they must attend court.
<b>II. SMALL CLAIMS</b>	
<b>Type of appearance presently set for September 19, 2022</b>	<b>Process for rescheduling</b>
First and only day of trial (including Rule 9.1 simplified trial and Rule 9.2 summary trial)	JCM will contact parties and counsel to reschedule.
Trial presently scheduled to commence on September 19, 2022, with subsequent trial dates	Parties and counsel will be expected to attend the next scheduled trial date after September 19, 2022. On this date, parties and counsel will address rescheduling the September 19, 2022 date with the presiding judge.
Continuation of trial where there <b>is</b> already a scheduled trial date before September 19, 2022 to address rescheduling with the presiding judge	Parties and counsel will be expected to address rescheduling with the presiding judge at a scheduled trial date before September 19, 2022.
Continuation of trial where there is <b>not</b> a scheduled trial date before September 19, 2022 to address	JCM will contact parties and counsel to reschedule.

Trial conference	The parties will receive notification from the Registry regarding the next date a trial conference will be scheduled.
Settlement conference	The parties will receive notification from the Registry regarding the next date a settlement conference will be scheduled.
Applications to a judge	The parties will receive notification regarding the next date they must attend court.
Payment hearings	The creditor/debtor will be required to file and serve a new summons (Form 12)/notice (Form 13) with the rescheduled date obtained from the Registry.  For payment hearings that were previously heard and adjourned for review on September 19, 2022, the parties will receive notification from the Registry regarding the new date.
Default hearings	The creditor will be required to file and serve a new summons (Form 14) with the rescheduled date obtained from the Registry.
<b>III. CRIMINAL (ADULT AND YOUTH)<sup>1</sup></b>	
<b>Type of appearance presently set for September 19, 2022</b>	<b>Process for rescheduling</b>
<b>A. IN CUSTODY</b>	
Any in custody appearance scheduled for September 19, 2022	JCM will contact counsel to reschedule. If not rescheduled, the matter will be call dated to September 15, 2022, at the court location where the matter was previously scheduled to proceed, or as otherwise directed by a JCM, at 9:30AM to fix a date. The court registry will prepare the process required to bring the matter forward for video attendance on that date.
Judicial interim release - new in custody charges on September 19, 2022	New in custody charges will be referred to the Justice Centre with the weekend bail procedures governing.

B. OUT OF CUSTODY	
<p>First and only day of trial on September 19, 2022</p>	<p>Adjourned to September 26, 2022 for a fix date, unless a new date for trial is obtained from a Judicial Case Manager before September 19, 2022.</p> <p>A bench warrant will be issued for all accused persons who have not rescheduled their first day of trial set for September 19, 2022. The bench warrant will be held and not executed until the next scheduled appearance date of September 26, 2022. If the accused person appears personally or through counsel/agent on or before September 26, 2022, the bench warrant will be vacated.</p>
<p>Trial presently scheduled to commence on September 19, 2022, with subsequent trial dates</p>	<p>A bench warrant will be issued for September 19, 2022 and will be held until the subsequent trial date unless adjourned before September 19, 2022.</p> <p>Parties and counsel will be expected to attend the next scheduled trial date after September 19, 2022. On this date, parties and counsel will address rescheduling the September 19, 2022 date with the presiding judge.</p>
<p>Continuation of trial where there <u>is</u> already a scheduled trial date before September 19, 2022 to address rescheduling with the presiding judge</p>	<p>Parties and counsel will be expected to address rescheduling with the presiding judge at a scheduled trial date before September 19, 2022.</p>
<p>Continuation of trial where there is <u>not</u> already a scheduled trial date before September 19, 2022 to address rescheduling with the presiding judge</p>	<p>Adjourned to September 26, 2022 to fix a date for your next appearance unless the next continuation date is already scheduled prior to September 26, 2022, or a new date for trial is obtained from a Judicial Case Manager before September 19, 2022.</p> <p>A bench warrant will be issued for all accused persons who have not rescheduled their first day of trial set for September 19, 2022. The bench warrant will be held and not executed until September 26, 2022, unless the next scheduled appearance date is before September 26, 2022 in which case it will be executed on that earlier date. If the accused person appears personally or through counsel/agent on or before September 26, 2022, the bench warrant will be vacated.</p>

Initial Appearance Court	<p>Adjourned to September 26, 2022, unless a new appearance date is obtained from a Judicial Case Manager before September 19, 2022.</p> <p>A bench warrant will be issued for all accused persons who have scheduled appearances on September 19, 2022 and have not prior to September 19, 2022 otherwise adjourned their matters.</p> <p>The bench warrant will be held and not executed until the next scheduled appearance date of September 26, 2022. If the accused person appears personally or through counsel/agent on or before September 26, 2022, the bench warrant will be vacated.</p>
Pre-trial conference	JCM will contact parties and counsel to reschedule.
Disposition	JCM will contact parties and counsel to reschedule.
<b>C. SPECIALIZED COURTS</b>	
New Westminster First Nations Court	Adjourned to September 22, 2022, unless a new appearance date is obtained from a Judicial Case Manager before September 19, 2022.
<b>IV. TRAFFIC, TICKET OR BYLAW MATTERS</b>	
Traffic, ticket or bylaw matters scheduled for September 19, 2022 are adjourned and will be rescheduled to a later date. A notice of a new Court date will be sent to the disputant by mail to the address on file with the Court.
